



2021-22 School Agreement

In consideration of City of Fountains School (COFS) enrolling _____, I hereby agree and accept this School Agreement and have initialed and signed below.

- _____ 1. I acknowledge receipt of and have read a copy of the enrollment documents and this School Agreement.
- _____ 2. A monthly Tuition of \$_____ is due on the first Friday of each month, August through April (a monthly statement is available upon request). A \$10/week late fee will be imposed after the 7th of the month if tuition has not been paid. If enrolling at any time after August, tuition shall be paid through May.
- _____ 3. Affiliation fees are to be paid in full by June 1st, 2021, or at the time of enrollment if submitting forms after this date. If fees are not paid in full at this time, COFS cannot guarantee placement.
- _____ 4. I may terminate this School Agreement with or without cause, upon thirty (30) days written notice given to the Administrator with the withdrawal date from school. No tuition or affiliation fee refunds shall be issued. If on the date the child is to be withdrawn, any tuition or extended-care expenses (if applicable) are owed, I shall promptly pay that amount to COFS. If I fail to give the school thirty (30) days written notice of withdrawing their child, one (1) month's tuition and extended care payment (if applicable) shall be due and payable on the date of withdrawal.
- _____ 5. I understand that in alignment with the school's philosophy, inspired by Waldorf education, COFS asks that media of all kinds (television, video games, radio, movies, computers, phones, tablets) be limited and censored appropriately. If I need information on what is suggested by the Waldorf philosophy, I may discuss this with my child's teacher.
- _____ 6. I understand when my child is ill, he/she may not attend school unless he/she has been fever-free for 24 hours without medication.
- _____ 7. I understand the importance of outdoor time for my child, even if he/she has recently been ill. I will bring appropriate clothing for the outdoor temperature.
- _____ 8. I understand and acknowledge that there will be no reduction in tuition for holiday closings, bad weather closings, non-attendance on school days and/or other scheduled school closings.
- _____ 9. COFS allows participation in its activities, services, events and programs by persons of any race, color, national or ethnic origin, religion, sexual orientation or gender. It does not discriminate on the basis of race, color, national or ethnic origin, religion, sexual orientation or gender.
- _____ 10. For the 2021/2022 school year, if you choose to disenroll you may request a refund based on the following:
 - Before June 1st- 100% refund on affiliation fees paid
 - June 2nd- July 1st- 50% refund
 - July 2nd- August 1st- 25% refund
 - After August 2nd- no AF refunds will be issued

The undersigned voluntarily and knowingly release City of Fountains School and any and all of its teachers and staff from any and all liability for bodily or personal injury, death or property damage arising out of the use by the undersigned or his/her/their children of the City of Fountains School indoor and outdoor facilities located at Keystone United Methodist Church, 406 W 74th St, Kansas City, Missouri 64114, and any or all other facilities and/or locations used by and/or occupied by City of Fountains School for educational activities during the enrollment of the student/s.
